

Privacy policy

[1] Les Foutoukours respects your privacy. As such, we are committed to protecting the personal information of our users. We have adopted this privacy policy (the "Policy") in order to be transparent about what data we collect, why we collect it, with whom we share it, how you can access it and how to correct it, if necessary. In this policy, the terms "Les Foutoukours Production Company", "we", "us" and "our" refer to Les Foutoukours.

[2] We recognize our obligation to manage your data responsibly. We do not and will not sell your data to third parties.

[3] This policy applies to the use of the <u>https://lesfoutoukours.com</u> website. Please read it carefully to understand when you provide us with your data and how we use it. **By using our website, you consent to the use of your personal information as described in this Policy.**

[4] In order to make this Policy as clear as possible, we have identified the occasions when a user could potentially share personal information with us. The Policy is therefore divided as follows:

[8] We automatically collect the following information through cookies or similar technologies:

Browser type and version

IP address

Page leading to the website

[9] We collect the following information when you first contact us or communicate with us:

Information voluntarily provided



[10] <u>Why</u>: The data collected allows us to analyze how our website is used and accessed, enabling us to enhance its functionality and optimize it to better meet the needs of our users. This data also enables us to offer you a quality service and to communicate with you in order to help you easily reach the information you are looking for.

[11] <u>Legal grounds</u>: necessary for our legitimate interests (improving and personalizing our products and services) and yours (answering your questions and allowing you to contact us).

[12] Please note that the information collected by cookies does not allow us to identify you personally. Also note that you can choose to refuse the collection of cookies:

- through your Web browser
- or our cookie banner.

[13] However, by refusing cookie collection, you may not be able to access certain parts or features of our website.

[28] How do we use your data?

The submission of your personal information through your use of our Site is governed by this Policy. As a user of our Site, you also agree to respect and protect the privacy of third parties.

[29] Specifically, we use your data for the following purposes:

To communicate for marketing, advertising or account management purposes

To compile statistics to guide business decisions

[30] Our use of cookies

[31] When you visit our website, you may provide us with information via cookies or similar technologies.

[32] Cookies are files containing a small amount of data about a given user. This data may include an anonymous unique identifier. Cookies are stored on the user's computer or on the hard disk of another device. They enable us to tailor your user experience each time you visit our site.

[34] With whom do we share your data and why?

[35] Under no circumstances do we sell our users' personal information. Your data is shared only in accordance with this Policy. When you consent to this Policy, however, we may share your personal information with the following parties:



[36] Third Party Suppliers: It is possible that, in the course of our business, we may need to share some of your data with certain third parties. For example, we may share some of your data with our IT suppliers, for the performance of their mandate or the execution of a service contract.

[37] In general, the suppliers we use will only collect, use and disclose your information to the extent necessary to perform the services they provide to us, such as hosting our website via ionos.

[38] However, some third-party service providers have their own privacy policies regarding the information we are required to provide to them when we use their services. With respect to these providers, we recommend that you read their privacy policies carefully so that you can understand how they will treat your collected personal information.

[**39**] Once you leave our website or are redirected to a third party website or application, you are no longer governed by this Policy.

[41] Parties with whom it may be legally necessary: we may disclose your information if required to do so by law or if such disclosure is necessary in order to:

- 1. Comply with the law or any legal process;
- 2. Protect the rights or property of Les Foutoukours;
- 3. To protect the security of our Website, our users and their data.

[42] Parties likely to be involved in a financial transaction: we may transfer your data following a change of control, merger, liquidation, or other transaction involving Les Foutoukours. The information required for this process will only be used to complete the transaction, and we will only disclose this information without your consent if we are permitted to do so by law. We will take the necessary measures to protect the confidentiality of this information and will destroy it if the transaction is not concluded or if its use is no longer necessary for the purposes of concluding the transaction.

[44] Your rights

[45] Data protection laws give you certain rights in relation to your information. In particular, you can:

1. Request access to your data in order to verify it. Please note, however, that we reserve the right to ask you for additional information to prove your identity;

2. Ask us to modify or rectify your data;

3. Ask us to delete personal data in our possession, unless we are required to retain it in order to comply with legal obligations, for example;

4. Object to the processing of your data, unless we have legitimate grounds which would override your rights or interests, or if we need to continue to process such data for the establishment, exercise or defense of a legal claim;

5. Ask us to restrict the processing of your data if it is incorrect, if you believe that our processing of it is unlawful or if we no longer need to process your data, but need to retain it for legal purposes;

6. Request your personal data and information in an accessible format;

7. Withdraw your consent to the processing of your personal data;

8. File a complaint with the competent authority if you believe that we are processing your data in violation of applicable data protection laws.

[46] Access to and control of your data

[47] You can check, modify or delete your personal information by sending us an e-mail at juliette@lesfoutoukours.com or via the "Contact" section on our website, or at the contact details available at the end of this Policy. We will respond to your request as quickly as possible. Please provide us with sufficient details so that we can identify you and respond to your request.

[48] Where your data is stored

[49] Your personal information is hosted in the following country(ies): USA . It is hosted on ionos servers.

[50] How long we keep your data

[51] We will retain all information collected for as long as is necessary to fulfil the purposes for which it was collected or for other essential purposes such as complying with legal obligations. We will destroy this data at the end of this period, or if you decide to withdraw your consent. If



you so request, once your data has been deleted, you will receive confirmation that your request has been processed.

[52] Security

[53] To protect your personal data, we take reasonable precautions to ensure that it is not lost, misappropriated, accessed, disclosed, altered or destroyed inappropriately.

[57] Age of consent

[58] We do not solicit or collect personal information from minors under the age of 14. If you are a parent or guardian and become aware that a minor under the age of 14 has provided us with personal information, please contact us. If we become aware that we have collected personal information belonging to a minor under the age of 14 without parental consent, we will delete any information that may have been collected.
